- Healthy and fit to operate the stall.

**Applicants should preferably fulfil the following criteria:**

- Successful applicant and stall assistant(s) must possess the WSQ Food Safety Course (FSC) Level 1 Certificate.
- Possess catering experience or experience operating in a school environment.
- Successful applicant is required to apply for a food stall license from Singapore Food Agency (SFA).

*Shortlisted applicants will be notified for an interview and will be required to provide food sampling for the School Canteen Selection Committee at the applicant's own expense.*
